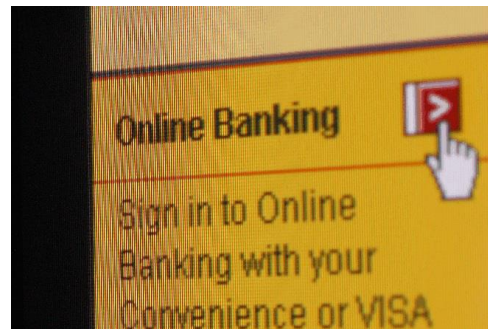
Any member in good standing that is interested in volunteering their time as a Director is encouraged to pick-up a nominating petition from one of the credit union offices.

To petition for nomination, each prospective Director must be in good standing with the credit union (all loans current and must have one member share) and a signed petition with 68 valid signatures of credit union members in good standing. This petition, a brief resume of your qualifications, and statement that you are willing to serve, if elected, must be returned to the credit union no later than September 8th, 2017.

Each Director is responsible for the safe and sound operation of a federally insured credit union. Every director is required to meet monthly with the Board of Directors at a regularly scheduled board meeting; be available to attend Special Board Meetings; be



able to work with the management and staff in resolving member inquiries. Each director, by federal law, disallows any form of compensation for the duties.



### **HOME BANKING**

Home Banking is a great opportunity for our members to review their account information online. You can also, transfer funds, make a loan payment. This will also save our members \$5.00 on a quarterly basis.

Home Banking is "FREE." Last year the credit union spent over \$30,000 for statements and the mailing costs associated with this expense.
